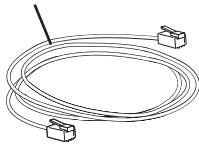

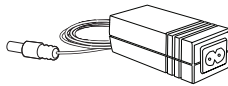

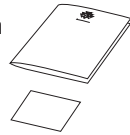

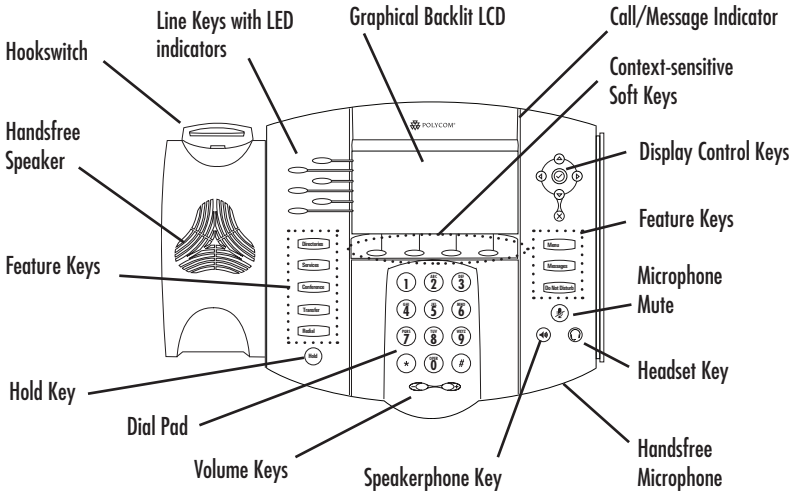

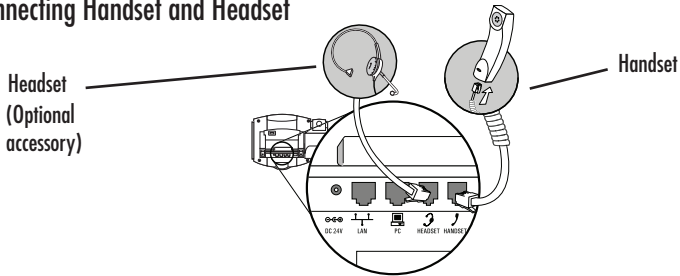

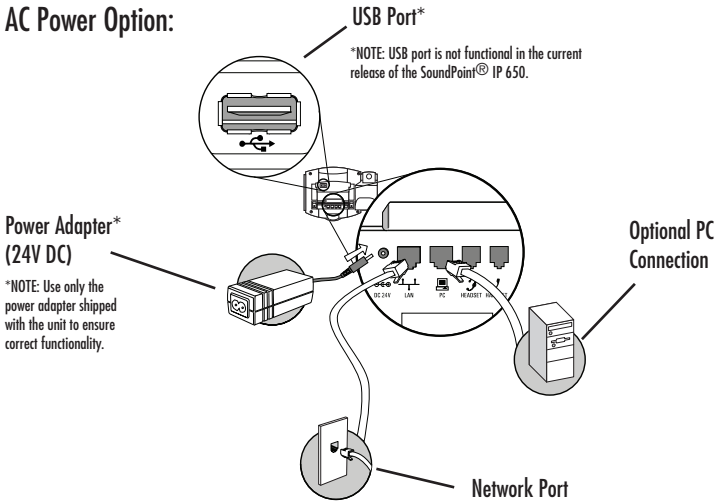
SoundPoint® IP 650 Installation

1 Connecting Handset and Headset

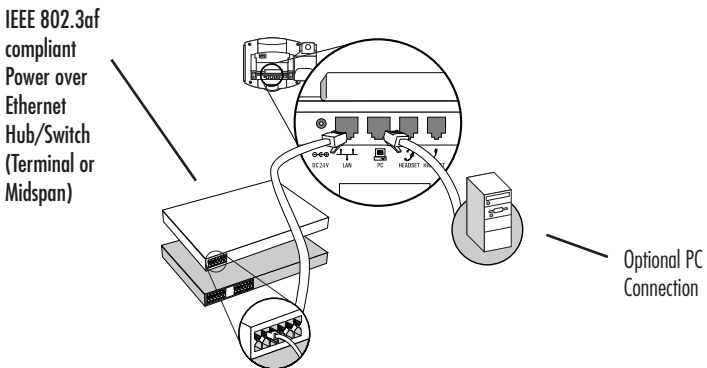


2 Connecting Network and Power

Power over Ethernet Option:

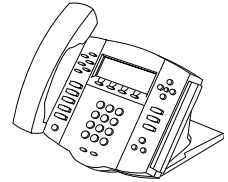
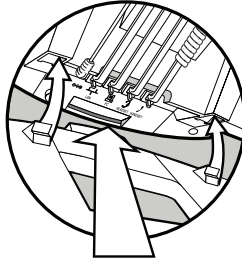
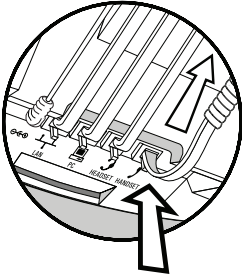


Attaching the Base Stand

The base stand can be attached to the SoundPoint® IP 650 in one of two ways:

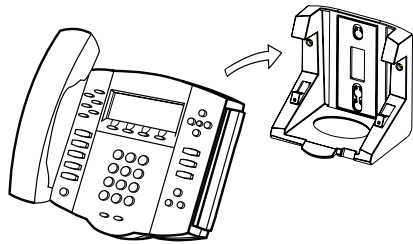
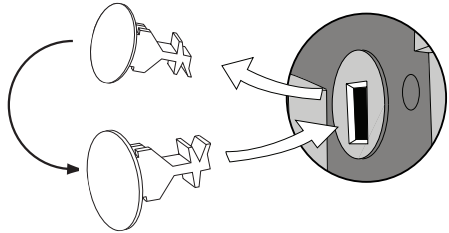
Deskmount Method:

- 1 Connect all cables.
- 2 Align tabs of base stand as shown.
- 3 Snap firmly into place.



Wallmount Method:

- 1 On the back of the phone, remove the wallmount tab located behind the hookswitch. Reposition it so that the end tab is facing up. This will ensure that the handset remains in place within the cradle in a wallmount position.
- 2 Fasten the wallmount unit to wall using wall anchors (not included). When wallmount is secured and all cables are connected, snap the SoundPoint® IP 650 into place.



SoundPoint® IP 650 Startup

As soon as power is supplied, the SoundPoint® IP 650 starts an automated process of establishing itself on the network and downloading software and applications.
